

SCAD ESL Key Steps

- ▶ **Step 1. Mapping report** uses desktop research to outline the main players in the audited economic sector. The output of this step is a mapping report which provides background information needed for the following steps.
- ▶ Step 2. Selectors of respondents and sector-relevant organizations draws upon the mapping report to compile a list of relevant public organizations to be assessed in the following experts survey and a comprehensive list of experts (both public officials and external experts) who should be invited to take part in the assessment.





SCAD ESL Key Steps

- ▶ Step 3. SCAD ESL Survey an anonymous online survey among a large pool of experts (preferable over 50).
- Step 4. Computation of the State capture indicators the data processing step where indicator scores from the SCAD ESL expert survey are computed together with complementary indicators.
- ▶ Step 5. Analysis of the results and integration with the other instruments the analytical step where the indicator scores are interpreted and vulnerabilities are outlined.


SCAD ESL Mapping Report

- Background information about the sector
- Main public organizations which are responsible for regulating the sector, for control and sanctions of companies operating in the sector and public organizations which are large clients in the sector.
- NGOs and branch organizations in the sector.
- ➤ Registries relevant to the sector: e.g. local procurement registries, registries of subsidies, lists of approved products/companies (e.g. lists of medicines which are covered by the national healthcare plan; list of approved fuel storage facilities, etc.).
- Main companies in the sector based on market share and procurement contracts.
- Short review of potential state capture-related incidents including allegations in reputable media outlets.








SCAD ESL Selectors of respondents

- Unlike other instruments relying on experts' assessments, SCAD ESL survey uses a large pool of both external experts and acting public officials
- Experts have to be familiar with some of the regulatory and control bodies in the sector.
- Different views and opinions are represented through the large sample
- ► High-pressure areas are those where the different experts' opinions converge.
- Discrepancies between public officials and external experts can be analyzed as well.



SCAD ESL Selectors of respondents


- ▶ **Public officials** are all people currently working at the management or expert levels in the public administration, in judiciary, prosecution, etc.
- **External experts** are:
 - NGO employees with expertise on corruption, conflict of interest, market competitiveness, etc.
 - Academia representatives with expertise on corruption, conflict of interest, market competitiveness, etc.
 - Ex-public officials who are familiar with at least some of the public organizations included in the survey
 - Heads of large businesses who are familiar with at least some of the public organizations included in the survey




Practical tips

- Use the mapping report to select respondents.
- ► Try to select a balanced group of respondents that includes all types listed above.
- Check your organization's contacts for additional experts you could add to the list.
- Ask your contacts to recommend more experts







- Standardized questionnaire, no changes in the questions apart from the list of public organization
- ► SCAD ESL should be implemented online using a software which handles filters (questions which are shown or hidden based on previous answers).




